## **Tuckaleechee Utility District Change/Disconnect Service Agreement**

It is the policy of Tuckaleechee Utility Department to require that the applicant seeking change or discontinuation of service be the responsible and current account holder currently residing at the service address. No other persons except the current account holder or property owner/landlord will be eligible to make any changes to the account. This includes, but is not limited to name change, transfer of service or discontinuation or disconnection of service.

Whenever an application is made for a change or discontinuation of service, all accounts involved MUST be brought current prior to any changes being made. The applicant is also aware that there may be additional applicable fees involved, depending on the type of service change requested. All requests **must be made in writing**.
